

CALL FOR ENTRIES – 2008 PHOTOGRAPHY/DIGITAL ART SHOW

UTAH COUNTY ART GALLERY

HEALTH & JUSTICE BUILDING, 151 SOUTH UNIVERSITY AVENUE, PROVO

Exhibition Dates: August 25 - September 27, 2008

Eligibility: Open to all Utah artists 18 years and older. Original artwork may be submitted in **Photography** (digital or film; traditional photographic image can be manipulated using filters or brushes) or **Digital Art** (composite image, collage or montage of original photography, text and/or digital art that is created using layering process) or **Digital Art/Painterly**, (single image that gives impression of a painting; must be created entirely using a computer software drawing program; may not be a photograph manipulated through a drawing program.) Size limit is 48"x48" and can weigh no more than 40 lbs. All pieces must be framed and wired (screw eyes and wire) to be accepted.

Submission of Art Work: Deliver art on **SATURDAY, AUGUST 23, 2008 from 10 a.m. to noon**, to the Health and Justice Building, 151 South University Avenue, Provo, Utah.

Two works of art may be submitted: A \$7.00 non-refundable entry fee will be charged per entry. If a work is sold as a result of appearing in this exhibit, Utah County Art Board receives a commission of 20% of the sale price. The board may use images of works for current or future publicity and reserves the right to restrict acceptance of art due to community standards; no nudes, racism, sexism, or radical politics.

Juried Show: Each category will be judged separately, with awards given for **1st place (\$100) 2nd Place (\$75), 3rd Place (\$50).... Best of Show will be awarded \$300 (Awards could increase)**

Insurance: While reasonable precautions will be taken against damage, theft, and loss, artists entering this exhibit assume all liability, and must sign a release form when submitting artwork.

Reception & Awards Ceremony: A reception honoring exhibiting artists will be held **FRIDAY, SEPTEMBER 5 from 6 to 9 p.m. Awards program begins at 7 p.m.** Refreshments and live music are planned.

Pick-up of Art Work: Artwork not accepted into the show may be picked up on Sept. 5, 6-9 pm. Accepted works must remain in the exhibit for the duration of the show and may be picked up on **Friday, September 26, 3:30 to 5 p.m. or Saturday, September 27 from 9 to 11 a.m.**
