

CALL FOR ENTRIES – 2009 SPRING FINE ART SHOW

Exhibition Dates: April 27 – June 26, 2009

Eligibility: Open to all Utah artists 18 yrs. and older. Original artwork may be submitted in oil, acrylic, watercolor, opaque watercolor, drawing or mixed media. No 3D, giclee, digital or Xerox copies, or art previously exhibited in a juried show at the Utah County Gallery. Size limit is 48"x48" and can weigh no more than 40 lbs. All pieces must be framed and wired (screw eyes and wire) to be accepted.

Submission of Art Work: Deliver art on **SATURDAY, APRIL 25 from 10 a.m. to noon**, to the Health and Justice Building, 151 South University Avenue, Provo, Utah.

Two works of art may be submitted. A \$10.00 non-refundable entry fee will be charged per entry. If a work is sold as a result of appearing in this exhibit, a commission of 20% of the sale price will be paid to the Utah County Art Board. The art board may use images of works accepted for current or future publicity. The art board reserves the right to restrict acceptance due to community standards; no nudes, racism, sexism, or radical politics.

Juried Show: This show is a juried show with cash awards. Artists will be notified of the decision of the jurors by postcard. Awards Are:

1st Place	\$400
2nd Place	\$250
3rd Place	\$150
Five Merit Awards, each	\$20

Insurance: While reasonable precautions will be taken against damage, theft, and loss, artists entering this exhibit assume all liability, and must sign a release form when submitting artwork.

Reception: A reception honoring exhibiting Artists will be held **FRIDAY, MAY 1** from **6 to 9 p.m.** at the building. The awards presentation will begin at 7 p.m. Refreshments and live music are planned.

Pick-up Art Work: Artwork not accepted into the show may be picked up during the reception on May 1. Accepted works must remain in the exhibit for the duration of the show and may be picked up on **Friday, June 26 from 3:30 to 5:30 p.m.** or **Saturday, June 27 from 9 to 11 a.m.**
